By entering the parade, you agree to abide by the following rules:

1. All parade entries must sign the waiver/agreement below.
2. No alcoholic beverages may be carried or consumed on your float.
3. No "burn outs" or power braking allowed; maintain your position in the parade.
4. No stopping on the parade route.
5. Nothing can be thrown from the moving units along the parade route.
6. Participants may not get on or off the moving units.
7. Parade route East on Johnson Drive, Monrovia to Nieman Road.
8. Line up starts at 11:30 a.m. at Monrovia going West on Johnson Drive.
9. The Parade starts at 1 p.m. **sharp**, do not be late.
10. Each Entry must be identified by a banner or sign.
11. Bring a copy of the completed entry form to the parade line up.
12. \$10 Entry Fee is due on parade day at lineup time, **Cash Only!**
13. To be eligible for CASH awards, entries must be checked in by 12:30 pm on Parade day.
14. Awards ceremony will be held immediately following the parade at the judges stand. Liability Waiver, Indemnification and Hold Harmless Agreement

In consideration of permission to participate in the Shawnee St. Patrick's Parade, the undersigned, individually and on behalf of all individuals participating in the undersigned's parade entry, including minors with the express approval of their parents and/or guardians (referred to collectively as "Releasor"), hereby agrees to release, covenant not to sue, and indemnify the City of Shawnee, Kansas, the Irish American Club of Johnson County, all Parade sponsors and volunteers and their respective officers, board members, employees, representatives, agents, successors, heirs and assigns (referred to collectively as "Released Parties") as follows:

1. Releasor understands that participating in the Parade, including but not limited to driving, walking or riding in the Parade, may involve hazards that expose the Releasor to a wide range of known and unknown and/or unanticipated risks that could result in physical or emotional injury, paralysis, death, dismemberment, loss or damage to the Releasor or Releasor's property and to third parties.
2. Releasor assumes full responsibility and liability for the risk of injury to all persons or property, including to Releasor, resulting from Releasor's participation in the Parade. Releasor understands that inherent risks are present in the Parade despite reasonable rules, procedures, supervision and safety equipment.
3. Releasor voluntarily releases and forever discharges and covenants not to sue the Released Parties from any and all costs, expenses, legal fees, losses, damages, liabilities or injuries to Releasor caused by any source or reason, including the Released Parties' negligence and/or gross negligence, arising out of, related to, or associated with the Parade.
4. Releasor shall defend, hold harmless and indemnify the Released Parties of and from any and all claims, costs, expenses, legal fees, losses, damages, liabilities or injuries which may in any way arise out of, relate to, be associated with or caused by Releasor's participation in the Parade, specifically including but not limited to Releasor's negligence.
5. If any part of the provisions of this agreement are held unenforceable, the remaining portions of this agreement shall be given full force and effect.
6. This agreement shall be governed by the laws of the State of Kansas.
7. By signing below, Releasor acknowledges: Releasor had sufficient time to read this entire agreement; Releasor carefully read and understands this agreement and agrees to be bound by its terms; Releasor's participation in the Parade is purely voluntary; Releasor elects to participate in the Parade despite the inherent risks associated therewith; Releasor is aware this agreement is a release of liability and waiver of Releasor's ability to sue the Released Parties for any damages in the event of injury, death, or property damage, and is also an agreement to indemnify, defend and hold harmless the Released Parties for Releasor's conduct; Releasor enters into this agreement of its/their own free will.
